**Summary D9C:** The total Δ9-THC content in this sample is 0.06%. For the most accurate Δ9-THC concentration, refer to the GC MS/MS section of this COA. This sample was tested using HPLC and GC MS/MS. HPLC analysis can yield inconsistent results for Δ8-THC and Δ9-THC due to isomer interference. GC MS/MS was employed to avoid this issue. Please note, if THCa is present, the Δ9-THC level measured by GC MS/MS might be higher due to decarboxylation.

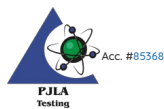
